

# Louisville Fire & Rescue Waiver

## Instructions

1. Participants age eighteen (18) and over complete Part A only and have it witnessed.
2. Participants under age eighteen (18) must have parent or guardian complete Parts A and B and have it notarized.

### Part A = Release and Hold Harmless

The undersigned understands, acknowledges, and agrees that riding in or upon a fire vehicle can result in injury to the person or damage to his or her property and is fully aware of the risks and hazards inherent in doing so and hereby elects voluntarily to enter upon said vehicle knowing this. IN CONSIDERATION of permission to ride in or upon said Fire vehicle, the undersigned hereby releases the Louisville-Jefferson County Metro Government and the Division of Fire, its agents and employees, and on behalf of the undersigned, his or her heirs, assigns, and legal representatives from any and all liabilities for personal injuries or property damage arising out of the undersigned's presence in or upon the Fire vehicle. The undersigned agrees never to sue any and all of the aforementioned entities in connection with any and all damages, claims, demands, rights and causes of whatever kind or nature based upon any injury to the person or property of the undersigned. The undersigned agrees for himself or herself and for his or her heirs and a legal representative to indemnify the Louisville-Jefferson County Metro Government and the Division of Fire, its agents and employees against and hold them harmless from any and all damages, actions, causes of actions, claims, judgments, cost of litigation and attorneys fees which may in any way at any time result from the undersigned's use of or the presence in or upon the Fire vehicle, including injuries to the officers, directors, employees or damage to the property of the Louisville-Jefferson County Metro Government and the Division of Fire.
